I hereby declare that I am eligible for an extension on the basis of maternity leave or significant/prolonged ill health, and can supply supporting documentation if asked. I understand that this extension will be subject to approval by the PSR Coordinator and will allow me to accrue the minimum annual points requirement of 15 points over 2 years (2011 - 2012) (including a minimum of 10 points in activities related to clinical practice) and the triennium requirement of 60 points with the end date of the triennium being extended by one year, observing the 12 point ceiling for each activity type for the extension period 2011-2012. Subject to approval of this extension, I am eligible to continue in the program in 2011 and to use the relevant title and post nominals. If granted this extension, I acknowledge that I have from 1 January 2011 to 31 December 2012 to accrue the minimum annual requirement of 15 points, that the twelve point ceiling still applies for each activity type during this period, and that the requirement for the triennium (which will now be extended by one year) of 60 points still applies.
- I have not met the criteria in 2011 and wish to recommence the triennium in 2012:** I have not met the minimum annual requirement of 15 points for activities throughout the year 2011 and/or for those in the final year of their triennium - I have not met the minimum requirement of 60 points for the triennium.
